• This is a diversified multi asset fund with a blend of active funds, passive vehicles and direct securities (individual bonds) in all major global markets.

• Asset allocation is centred around an equity weight of 55% and will typically be in the 45% to 65% range, subject to risk tolerance levels and the fund manager's outlook.

The fund will invest in global equity markets, with regional exposure broadly weighted to reflect relative market sizes.
Fixed income exposure is primarily a mix of regionally diversified G7 government bonds and global corporate bonds, and can also include other credit assets, as appropriate.

Currency Hedged Share Class

The hedged share class translates the return stream of the base share class (\$) into the investor's currency, with the aim of mitigating the impact on returns from exchange rate movements. While this hedge is not perfect, it aims to protect investors from significant currency fluctuations between base (\$) and currency share class.
