• This is a diversified multi asset fund with a blend of active funds and passive vehicles in all major global markets.

• Asset allocation is centred around an equity weight of 100% and will typically be in a 90% to 100% range, subject to risk tolerance levels and the fund manager's outlook.

• The fund will invest in global equity markets, with a bias towards the UK relative to its weighting in the global market.


Geography
